Holy Family Catholic School, in partnership with generous donors, is proud to offer the Holy Family Saintly Scholars Program (HFSS): 50% tuition for two years to newly enrolled families from PK3-6th grade. Families must be new to Catholic education in the Diocese of Fort Worth. HFSS is not a need-based program. It is a three-year enrollment incentive program to gain new students. Spots in this program are limited to funding and based upon the current class census at HFCS.

The program includes discounted tuition in year one and two, and full tuition in year three. If families leave prior to the end of the three-year program, they will be charged a \$1000 fee per discounted semester that the student attended HFCS.

Information provided on this application will be subject to policy 3240 in the Diocesan Catholic School Handbook.

“Any information submitted in or with any financial aid application (including FACTS) may be shared with the Catholic Diocese of Fort Worth, the Catholic Diocese of Fort Worth Advancement Foundation, their affiliates, any tuition assistance board of the diocese, parish, or school, or the Stephen Breen Memorial Foundation to consider in awarding financial aid or developing additional tuition assistance programs.”

## **Program Requirements**

While in this three-year program, families must be practicing Catholics and at minimum attending Sunday mass.

Families will have a requirement of 30 additional service hours, beyond the 30-hour requirement at registration. These hours are not eligible to be “purchased.” These service hours can be composed of direct service to the school or participation in Holy Family Catholic Church parish activities and ministries (bible studies, Lenten/Advent programs, Faith Formation, Fullness of Truth and other Catholic Conferences, etc). A list of eligible service activities will be provided each year.

Tuition will be paid at the start of semesters 2-4. In year three, standard tuition payment options will apply. For example, the payments would be per below:

- Semester 1: Free
- Semester 2: \$2,800
- Semester 3: \$2,800
- Semester 4: \$2,800
- Third year: Parishioner rate (currently \$8.4K) or applicable rate
